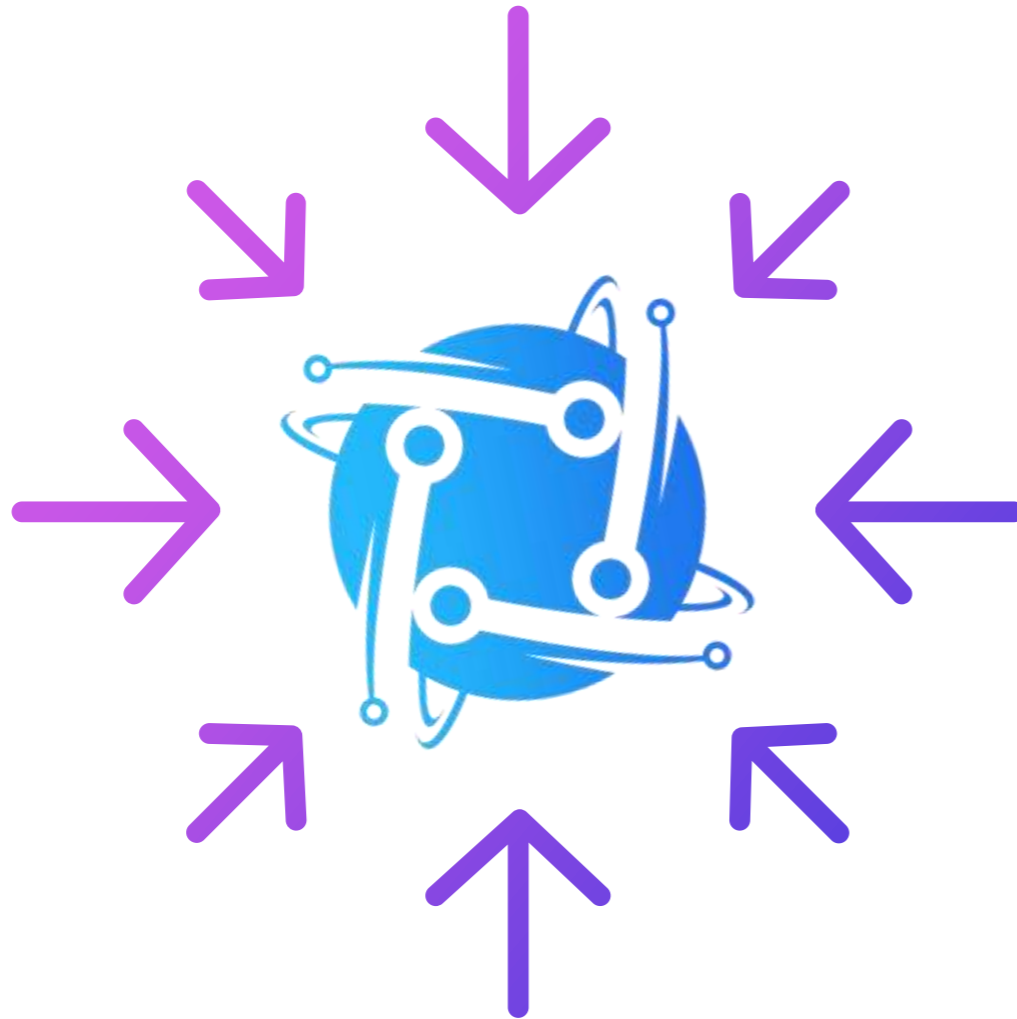

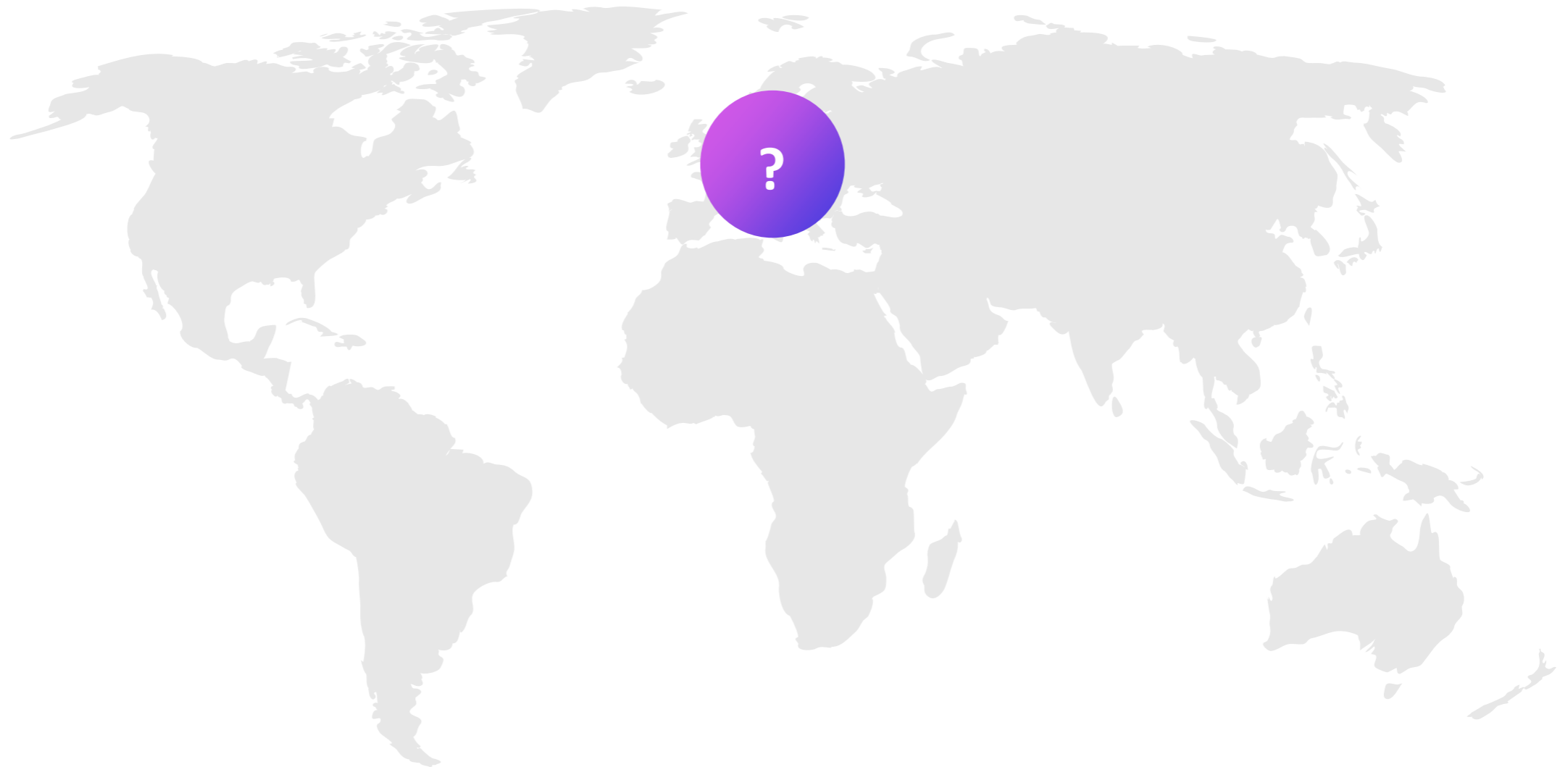
## Waspchain Top 100 Token Holders

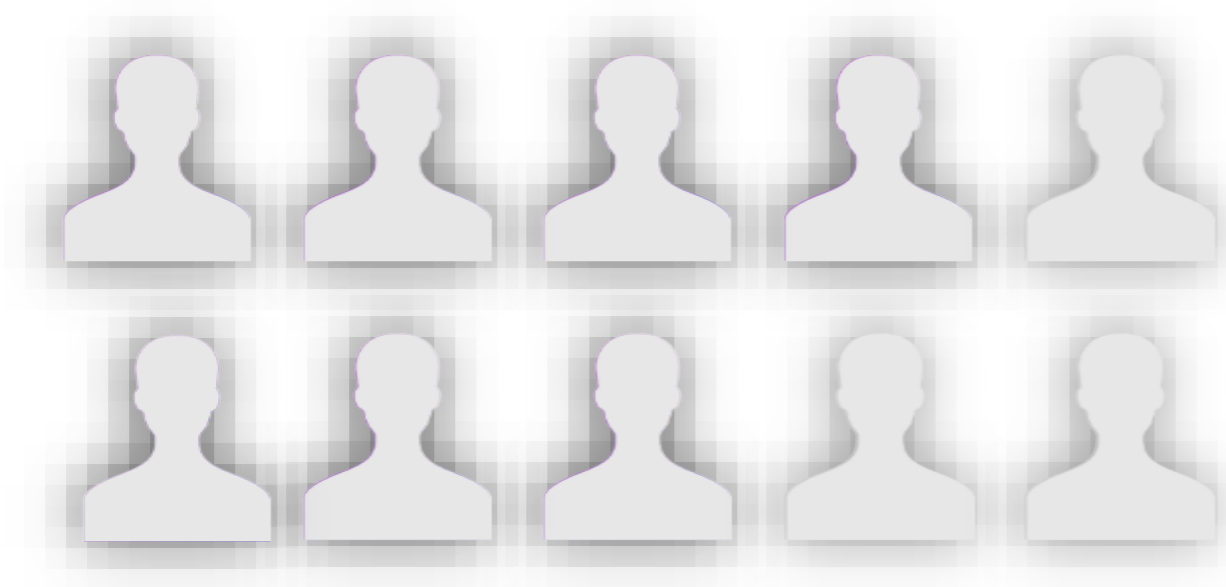
