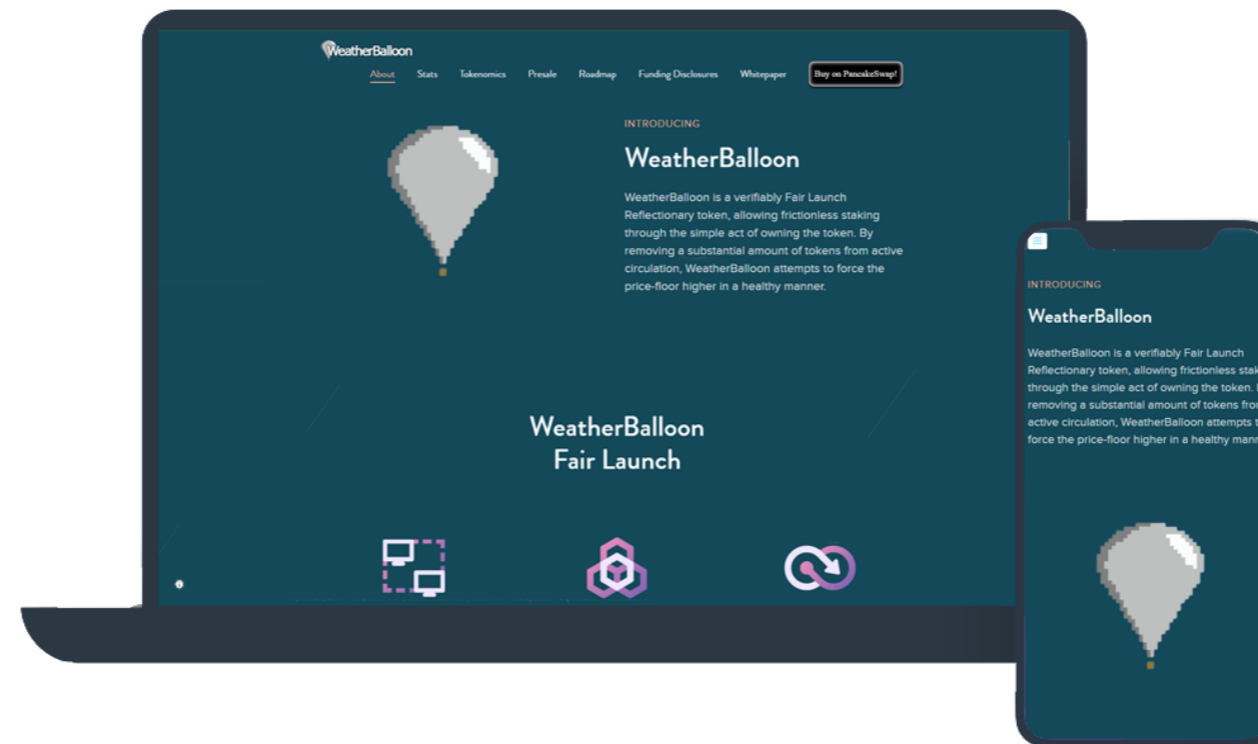

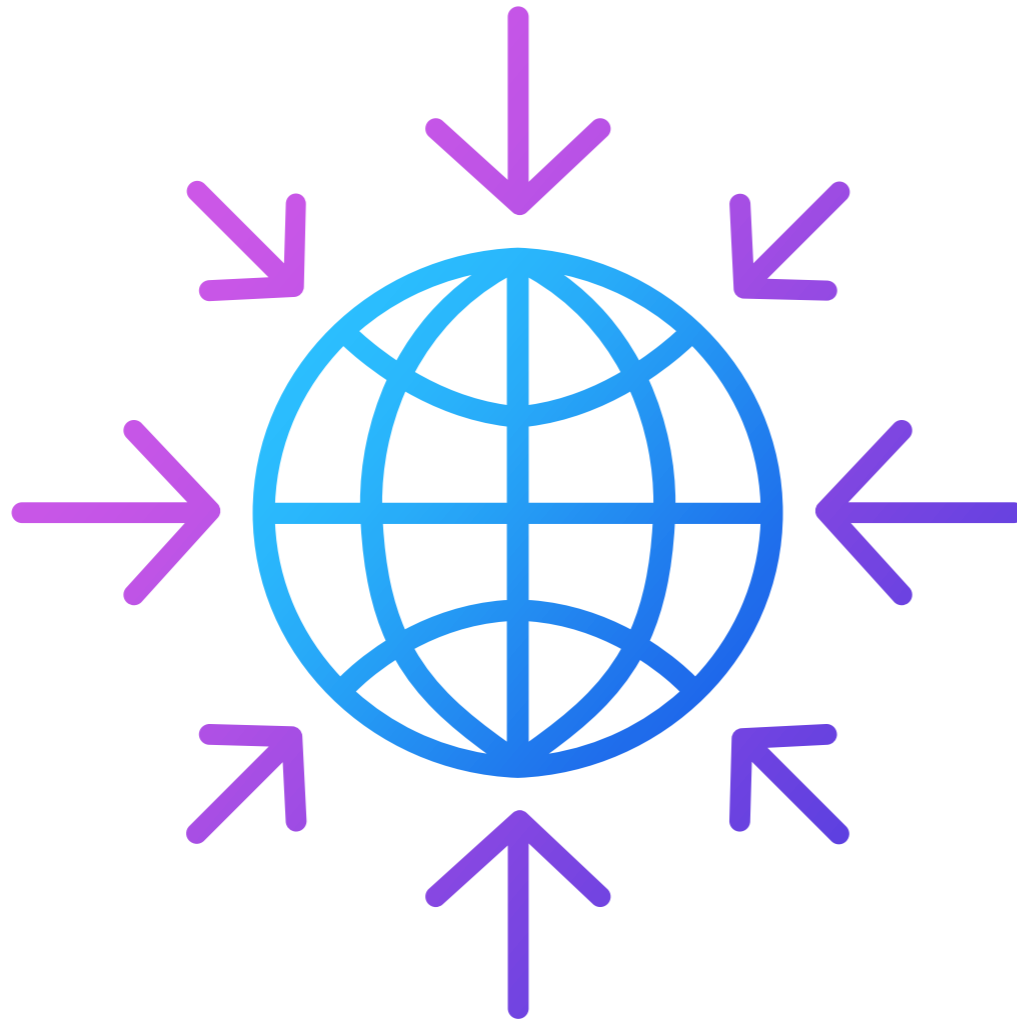

# Social Media – Final Thoughts & Suggestions for Improvement

Overall the team seems to be active across multiple social media platforms. We found a healthy amount of activity on Twitter and Telegram.

We were able to locate the twitter for the lead developer however there does not appear to be a dedicated twitter account for the core project. The subreddit was lacking content however this appears to be a fairly new project so we expect that to change over time.

A discord was found in the whitepaper however appears to be inactive at this time.

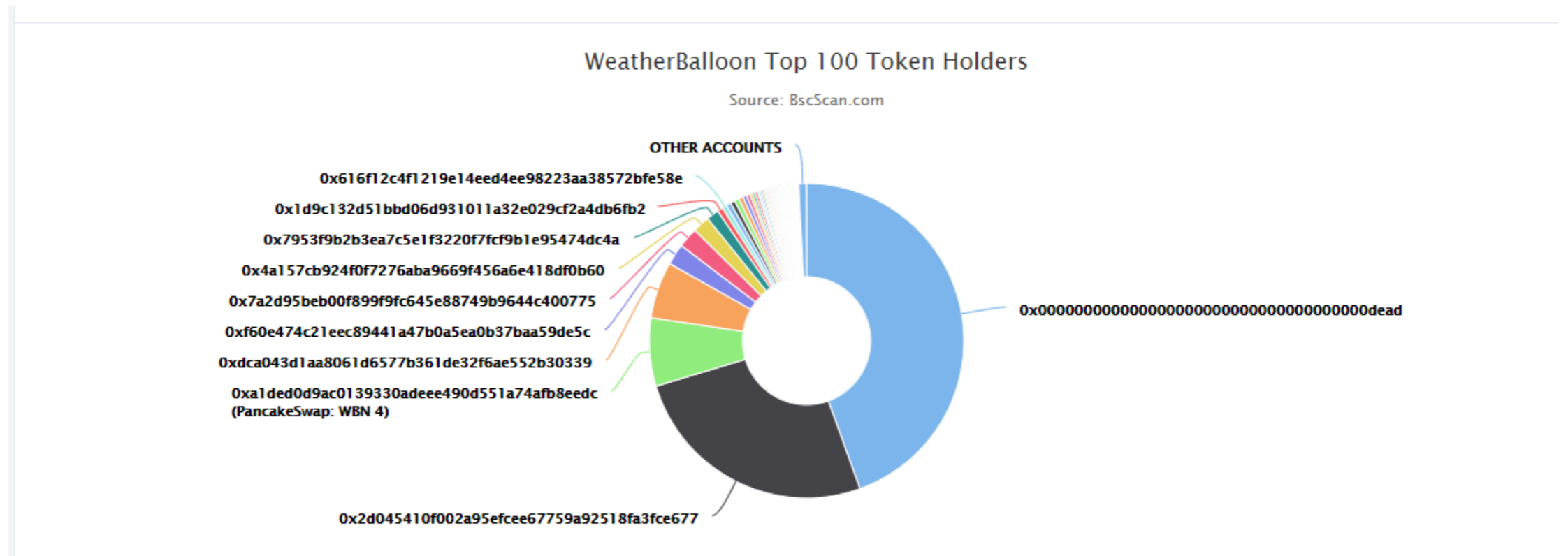
## Suggestions for Improvement

1. Have a pinned post on the WeatherBalloon subreddit describing the project and its goals.
2. Consider adding an official WeatherBalloon Twitter (the one we found appears to be the developer)
3. Consider adding WeatherBalloon Facebook page.
4. Consider using discord or removing it from the whitepaper to avoid confusion.



# Top Token Holders

At the block number indicated on the cover page of this report, 44.5% of the supply appears to be burned. The largest holder is the PancakeSwap liquidity pool,



[0x00dead](#) – 44.5% of the supply was burned at the time of audit.

[0x2d045410f002a95efcee67759a92518fa3fce677](#) – 25.8% of the total supply was held in a smart contract at the time of audit. We have confirmed that this contract contains tokens that are locked for various timeframes in DxSale.

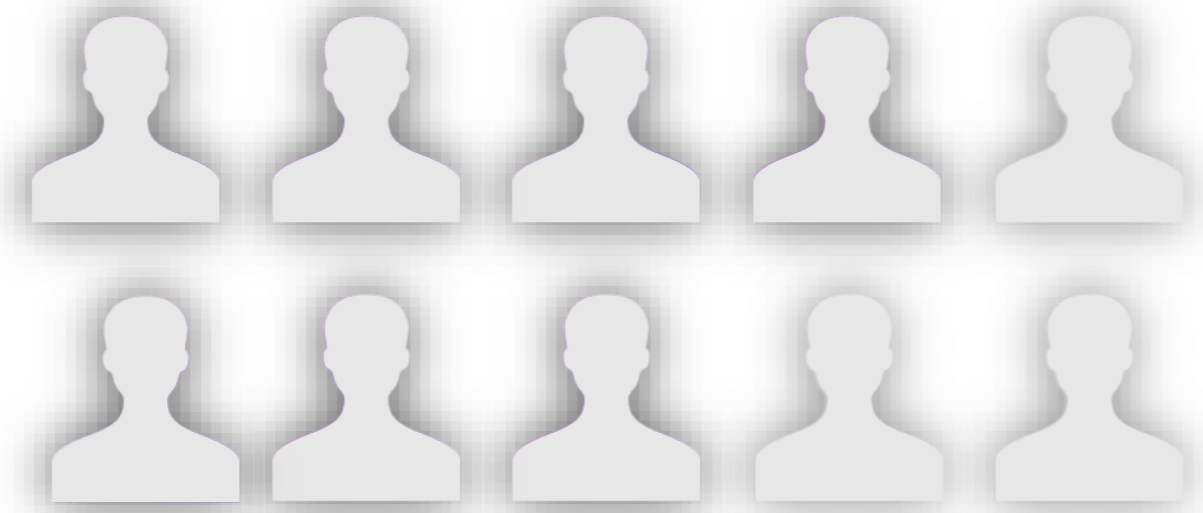

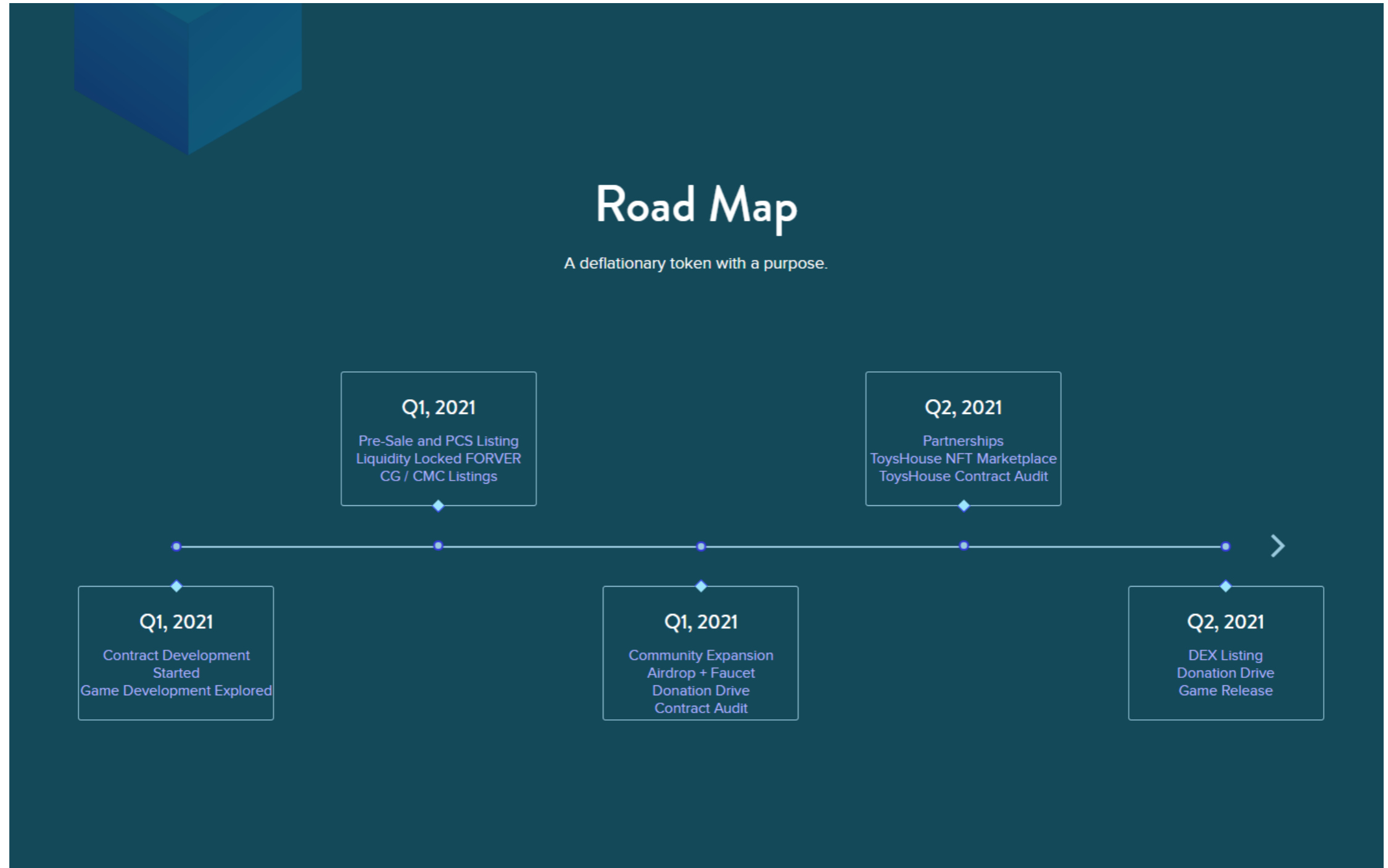

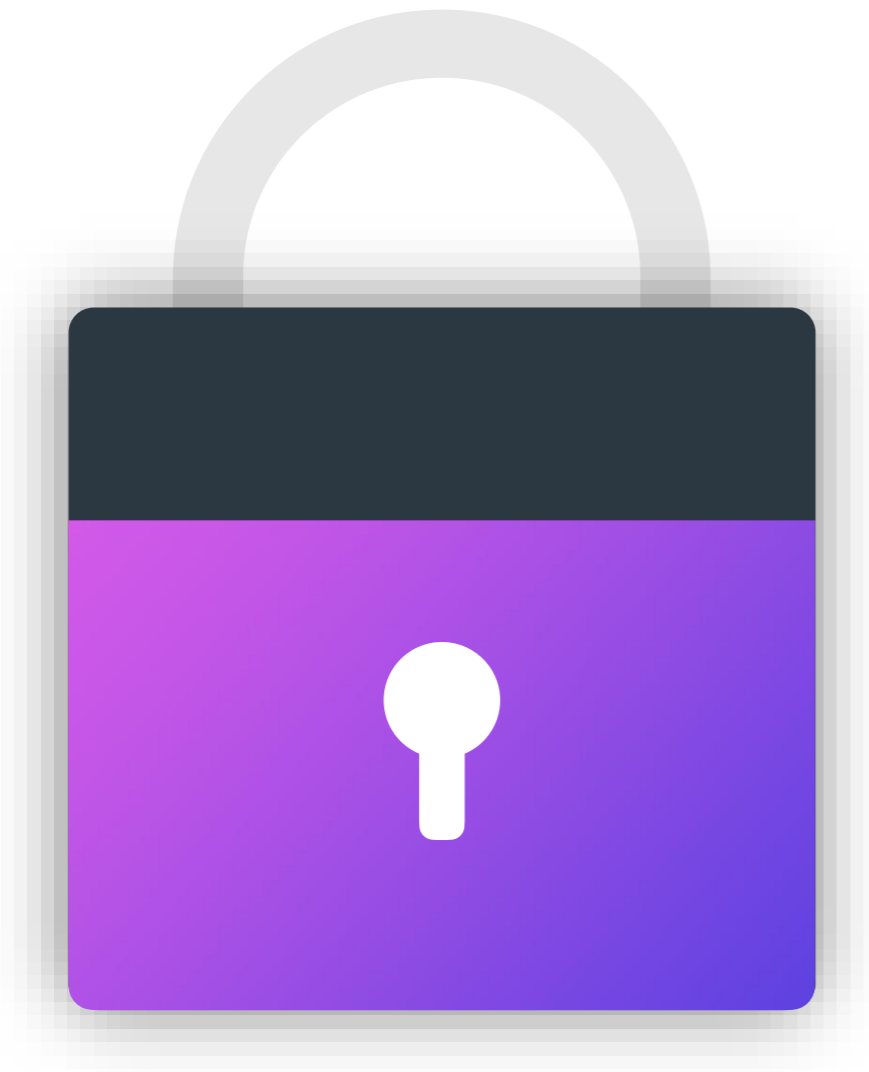
