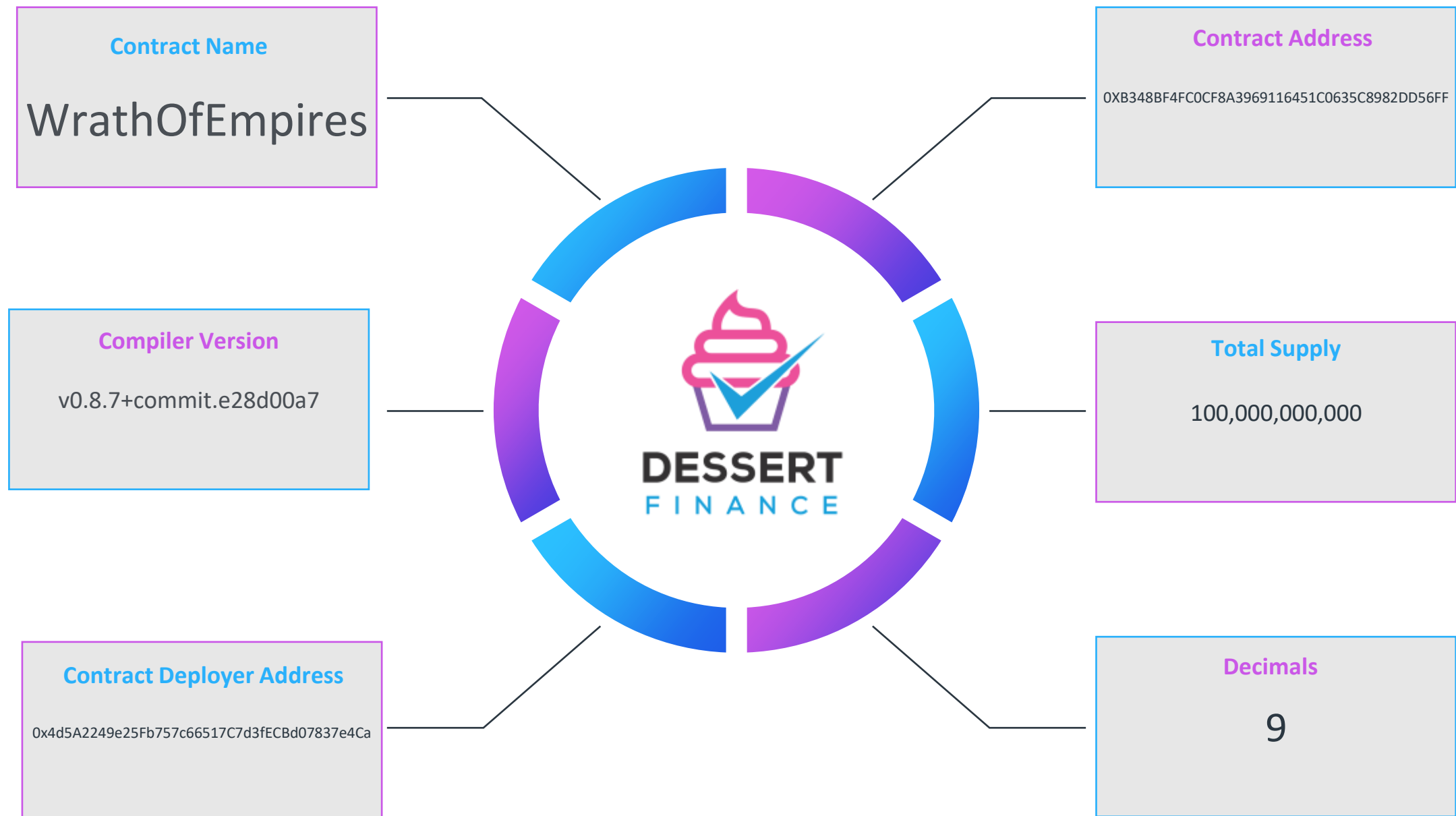

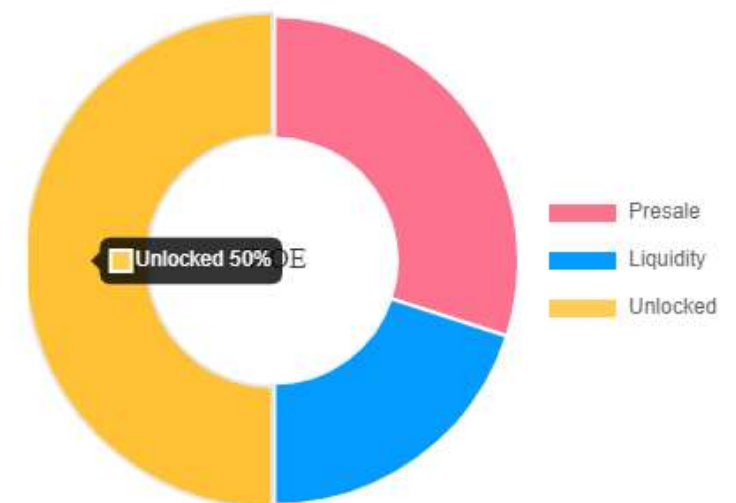

An error in the code was found, the code appears to send 98% of every transfer to the marketing wallet instead of 2%. We recommend redeploying with fixes in place swapping the amounts to send the proper 2% to marketing and 98% to the recipient.

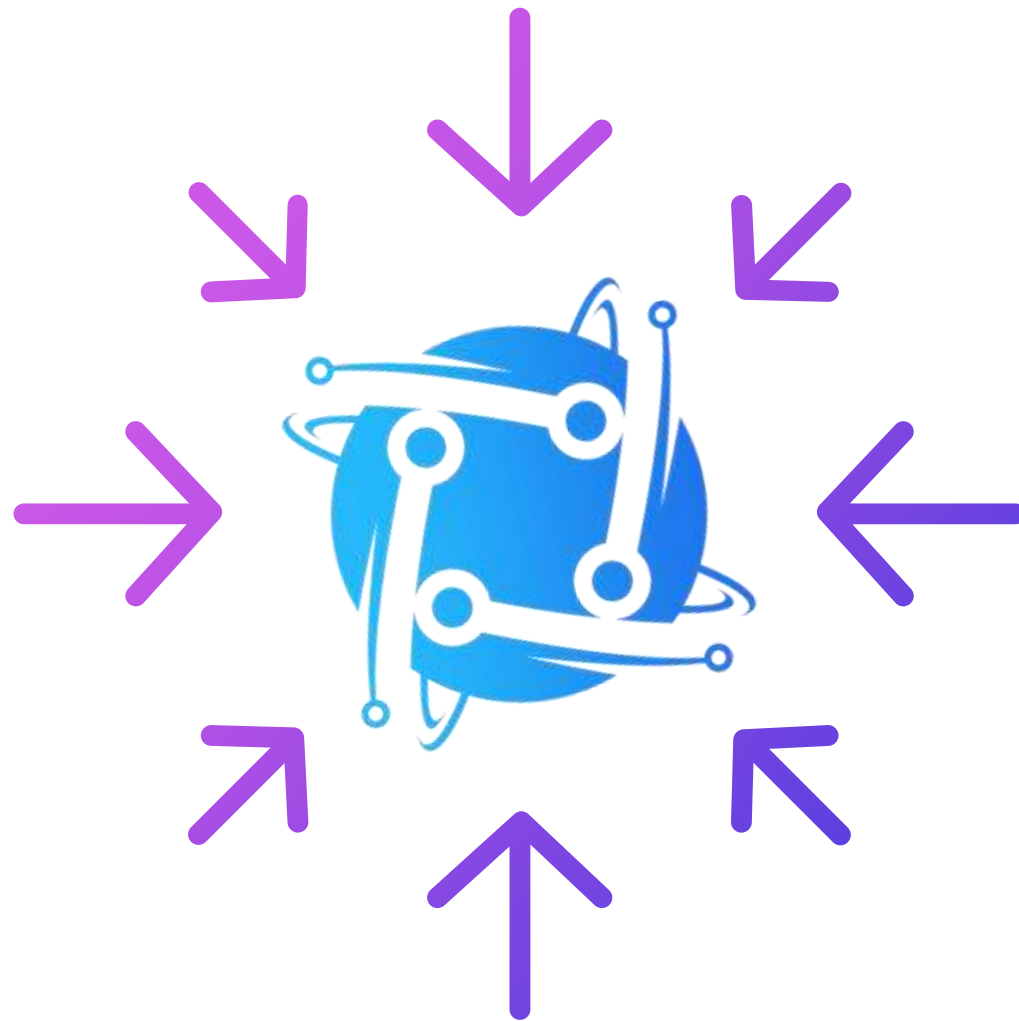

The website contained multiple JavaScript errors. Multiple typos and grammatical errors were present, and we found a valid SSL certificate allowing for access via https.

No additional issues were found on the website.

Website Part 3 – Responsive HTML5 & CSS3

No issues were found on the Mobile Friendly check for the website. All elements loaded properly and browser resize was not an issue. We found multiple spelling errors throughout the website and were able to locate the main character image on the website as non-original free content and additional assets from the game Paladins. Dessert Finance cannot confirm usage rights.

Multiple JavaScript errors were found. No issues with loading elements, code, or stylesheets.
