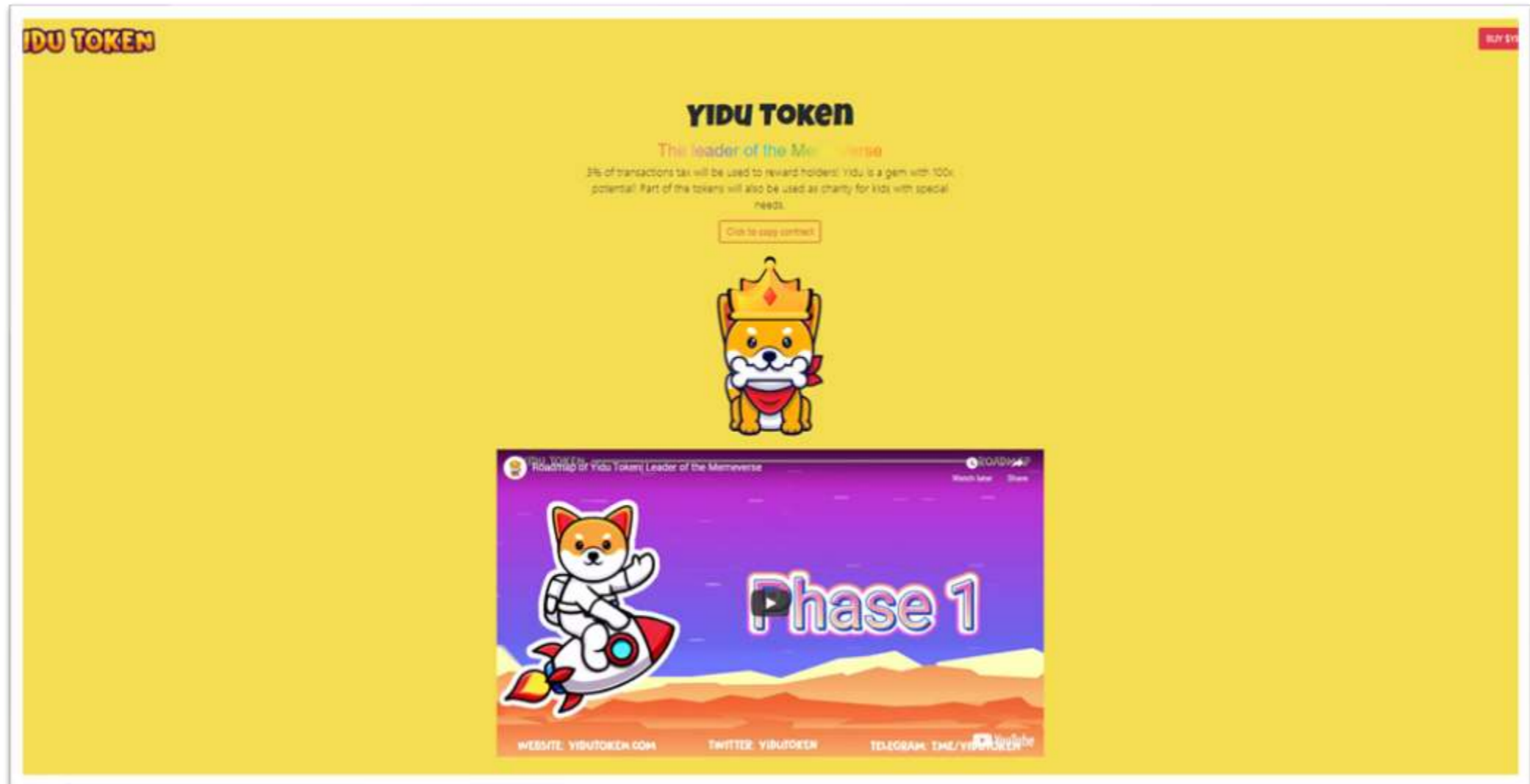

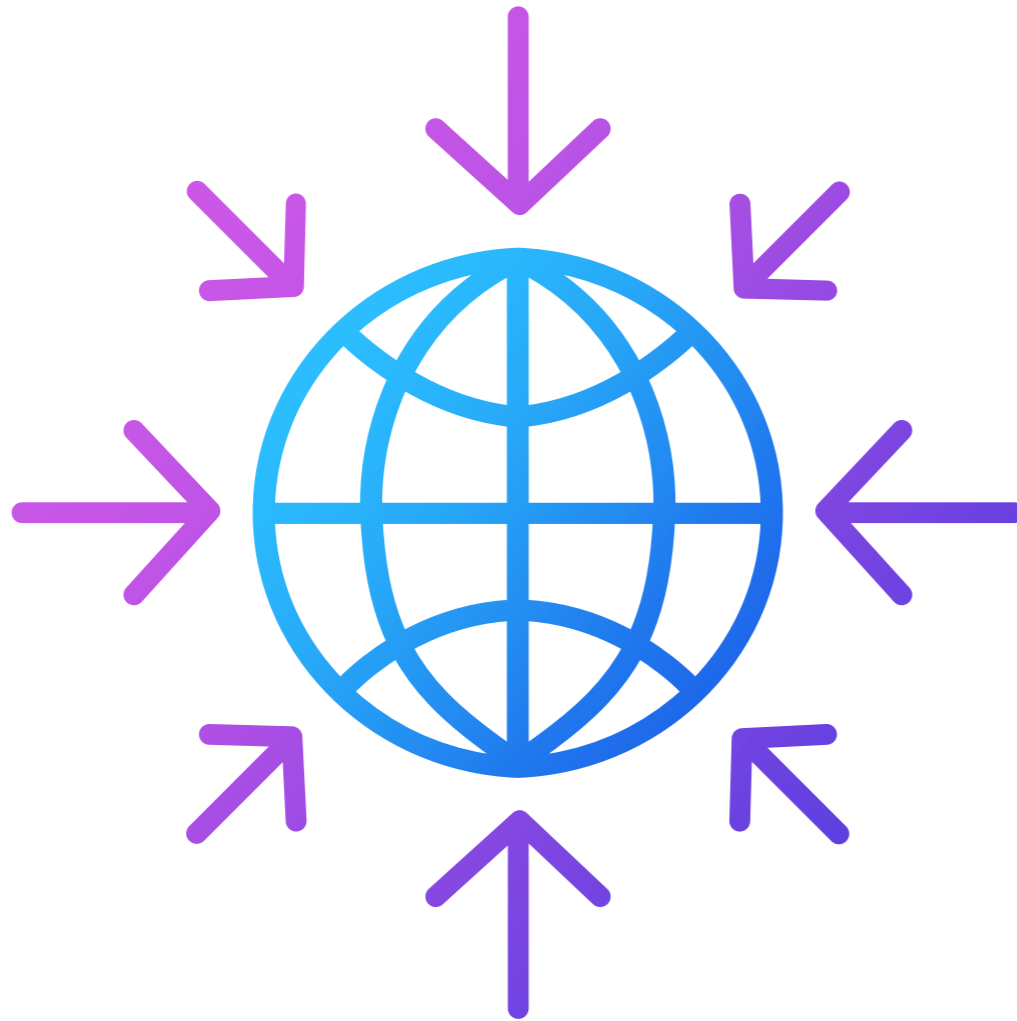
Above images are actual snapshots of the current live website of the project.

No issues were found on the Mobile Friendly check for the website. All elements loaded properly and browser resize was not an issue. The team has put a considerable amount of thought and effort into making sure their website looks great on all screens.

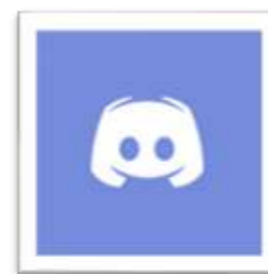

Social and Web – Final Thoughts & Suggestions for Improvement

We were able to track down two social media channels for the project. Social Media channels included Twitter, Telegram, Discord, Instagram and YouTube. All social media channels had a healthy amount of activity.

We do not see transaction fees clearly listed on the website, we are able to validate that there is a 14% fee on every transaction. 7% is added to liquidity, 3% is distributed to the holders, 2% is burned, and 2% is for buybacks. *✓ Resolved – Fees clearly listed on website.*

We found multiple dead links on the website including: Tokenomics and Fair Launch Countdown. The Twitter link on the top of the webpage does not redirect to an account. *✓ Resolved – Drop downs have been removed and relocated, Twitter link fixed.*

There is also a lot of empty space in the middle of the website. We would like to see this removed or filled with content as users will miss important information below. *✓ Resolved – Website was overhauled and empty space was removed.*

As this is a project with a charity aspect, we would like to see a letter from a charity providing proof of origination of donations or a social media post tagging the project made as an added layer of transparency to let users know that their money is going where it should. At this time we have no reason to suspect any misuse of funds, this is simply suggested best practices for cryptocurrencies with charity aspects.

Suggestions for Improvement

1. Create plan to receive a donation origination letter from charities that are being donated to or social media post mentioning the project by the charity.
2. Update domain registration to 3+ years *✓ Resolved*
3. We recommend fixing JavaScript errors on the website as well as dead links and style issues *✓ Resolved*
4. Consider adding an additional social media channel *✓ Resolved*



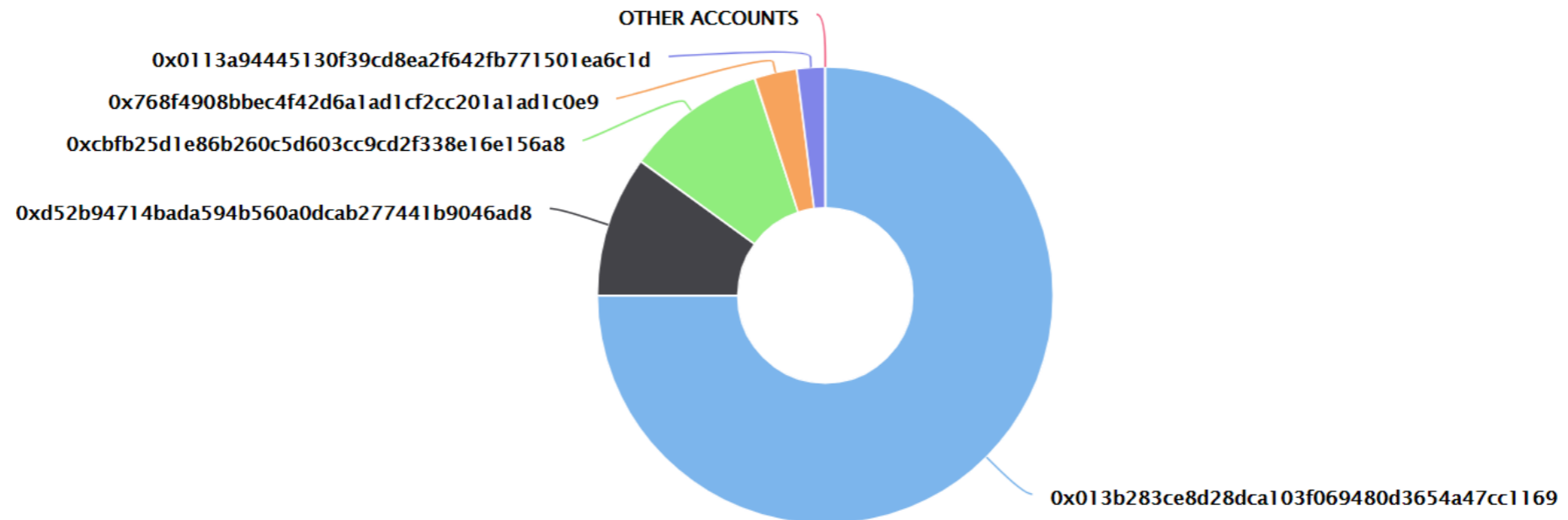
Top Token Holders

1. [0x013b283ce8d28dca103f069480d3654a47cc1169](#)– the top token holder was a wallet holding 75% of the total supply. This wallet will be used for a private sale (10%), Moved to Pancakeswap (40%) and the rest will be burned (25%)
2. [0xd52b94714bada594b560a0dcab277441b9046ad8](#)– the 2nd largest holder was a wallet containing 10.0% of the supply. This is a team held wallet to be used for marketing and development
3. [0xcbfb25d1e86b260c5d603cc9cd2f338e16e156a8](#)– the 3rd largest holder was a wallet containing 10.0% of the supply. This is a team held wallet.

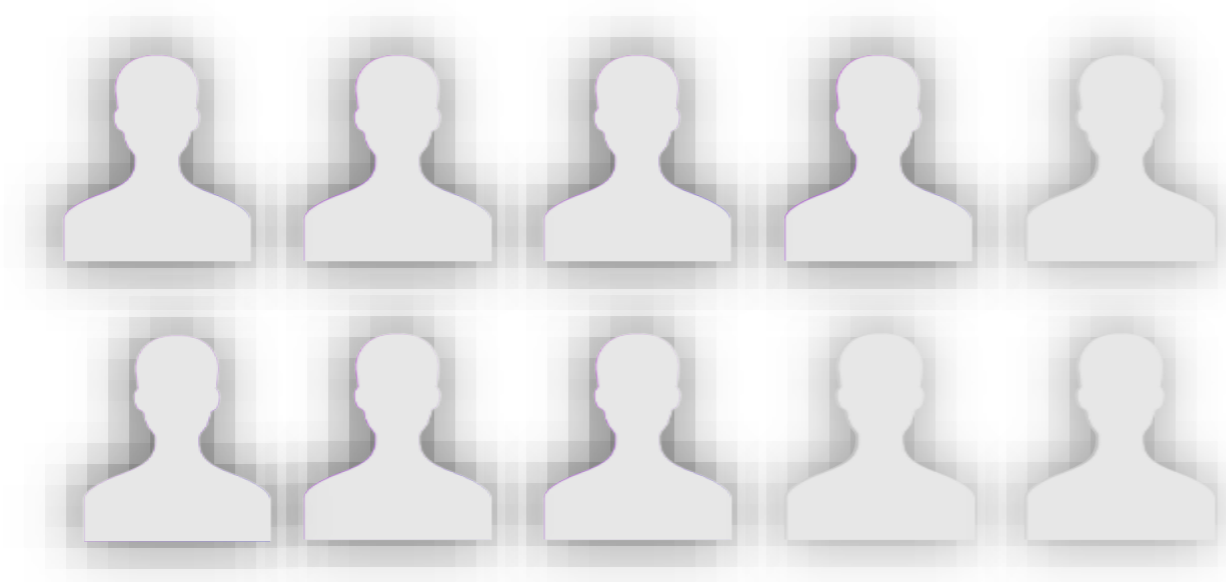
Location Audit

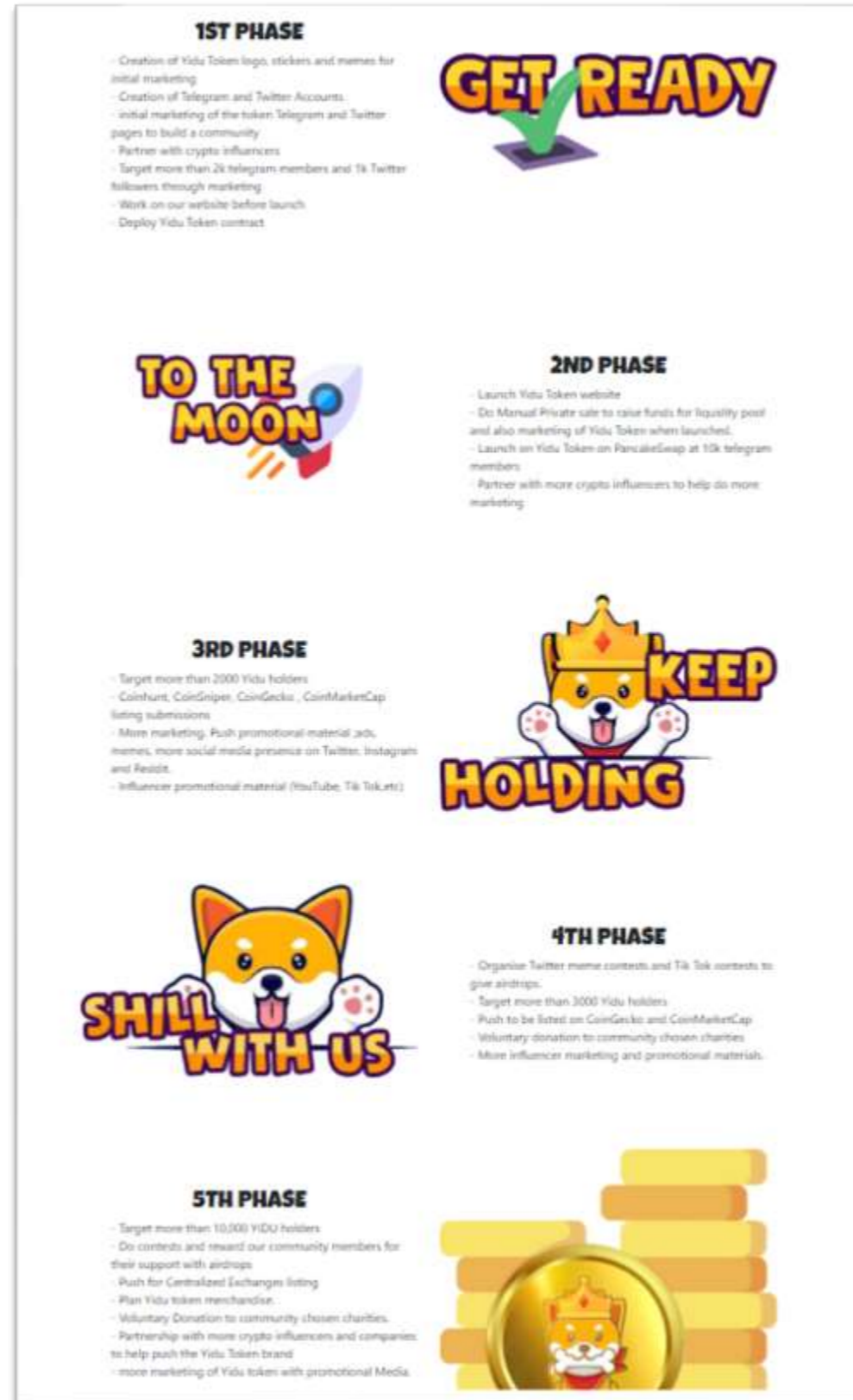
